Fees Outstanding appeal to EPTA

The outstanding fees was discussed, an appeal
was also made to the EPTA members to help the
school to recover the outstanding fees.

The Management of school has informed to the
EPTA Members, that as a difficulty raised due to
prevailing Covid-19 Pandemic in resumption and conduct-
ing of physical school, though a fees increase of
12% over the fees applicable for the academic year

2019-20 was approved for the academic year 2020-21 and 2021-22, but the school Management has not increased the approved fees increase of 12% for the academic session 2020-21 and has charged the same fees as was charged in academic year 2019-20

Considering the fact that the Covid-19 pandemic has had its damaging effect on the financial condition of several families and to enable the parents to ensure a smooth flow of education of their wards and regular payment of fees to the school, the management has considered the request of parents sympathetically and has granted a waiver of 25% in the fees for the academic year 2020-21.

Further to above, the management has approved allowed a waiver of 12% equal to approved increase ^{fees} in the fees for the academic year 2021-22 solely on humanitarian grounds and in addition to and additional 10% fees waiver in the fees for the academic year 2021-22 solely on humanitarian grounds.

06 * Executive Members' Feedback -

E-PTA members were appealed to give their valuable feedback regarding the school. E-PTA members appreciated the efforts taken by the management, school and teachers for conducting online as well as offline classes smoothly.

07 * Fees approval for academic year 2022-23, and 2023-24

School management has proposed the increase in school fees by 15% over the fees applicable for the academic year 2021-22.

The above proposal has been considered by the Executive Parents Teachers Association (hereinafter referred to as "EPTA"), keeping in mind the











