## **Minutes of the meeting:-**

1.	Chairperson of the EPTA, Mrs. Arti Choubey, Principal extend ended a warm welcome to all the members of the parent representatives and teachers' representatives of the EPTA for the session 2021-22.
2.	Chairperson briefed the agenda and shared the vision and mission with the members of EPTA with great pride, she shared the awards, accreditation, Atal Tinkering grants and other collaborations that the school is taking for the development of students. Skill integration -NEP 2020 was discussed in which the integration of 21 <sup>st</sup> century skills make the student an all-rounder. Best practices of online schooling were briefed. Activities like peer teaching, E- Birthday cards, energizer, Awakened citizen programs etc were used in the school for making the teaching fruitful.
3.	Ongoing initiatives like Atal Tinkering lab, self-paced learning, Remedial classes, Achiever's class, Intra MGS competitions, TCS collaboration etc were shared and are taken in MGS level.
4.	School initiatives like Mini-miracle, Art integration, webinars etc were shared and all these activities are taken by the teachers to make teaching interesting.
5.	Parents feedback analysis was shared with the executive members. Parents are satisfied with the online school and their individual satisfaction feedback were shared in the meeting.
6.	CBSE result of std X 2020-21 was shared and the chairperson congratulated the toppers.
7.	Achievements and Awards received by the students of the school for the academic year 2021-22 till date was shared with the members.
8.	Upcoming events of the school like MGS Mega event, Pi ( $\pi$ ) Day etc was shared

9.	<p>Details of outstanding fees as on 22.12.2021 was shown to the EPTA members. EPTA was appealed for the recovery of outstanding fees. The management of school has informed to the EPTA members, that as a difficulty raised due to prevailing Covid -19 pandemic in resumption and conducting of physical classes in the school, though a fees increase of 7% over the interim fees applicable for the academic year 2019-20 was approved for the academic year 2020-21 &amp; 2021-22, but the school management has not increased the approved interim fees increase of 7% for the academic session 2020-21 and has charged the interim same fees as charged as academic year 2019-20.</p> <p>Considering the fact that the covid – 19 pandemic has had its damaging effect on financial condition of several families and to enable the parents to ensure a smooth flow of education of their wards and regular payment of fees to the school management has considered the request of parents sympathetically and has granted a waiver of 10% in the interim fees to the Academic year 2020-21.</p> <p>Further to above, the management has allowed a waiver of 7% equal to approved increase in the interim fees of the academic year 2021-22 solely on humanitarian grounds.</p>
10.	<p>To help parents to pay the outstanding fees in 8 installments without any interest the school has partnered with Grey Quest. The parents who are in need can avail this facility without any difficulties.</p>
11.	<p>Feedback was taken from the parent EPTA members. The efforts taken by the school for the smooth conduction of academics both online and offline was highly appreciated by parents. As of now, school has reopened for std VIII-X and planning to reopen by Jan 15<sup>th</sup> the Omicron cases of India is under control (for Std I-VII)</p>
12.	<p>Fees Approval structure for the session 2022-23 and 2023-24 was shared and discussed. Parents opinion was taken.</p> <p>School Management has proposed the increase in school fees by 15% over the fees applicable for the academic year 2021-22.</p> <p>The above proposal has been considered by the Executive Parents’ Teacher Association(hereinafter referred to as “EPTA”),keeping in mind the various factors mentioned in section 9 of the Maharashtra Educational Institutions(Regulation of Fees)Act,2011(hereafter referred to as “Said Act’) and on finding the aforesaid proposal to be reasonable the EPTA has approved the increase of school fees by 15% over the fees applicable for the Academic Year 2021-22.This approved fees will be applicable for the academic sessions 2022-23 &amp; 2023-24.</p> <p>As of now, proceedings are pending before DFRC relating to the increase of fees for the year 2019-2020 and therefore, presently the increase is being proposed on the fees agreed by the EPTA meetings for deciding the increase in fees for the year 2021-22 &amp; 2021-22. In case any order is passed by DFRC allowing the increase/decrease for the aforesaid year, then the proportionate quantum will be added/deducted in the fees that will be finalized/approved by the EPTA for the AY 2022-23 &amp; 2023-24.</p> <p>Though the above increase of fees has been approved by the EPTA, in case of any difficulty in resumption and conducting of physical classes in the school., the School Management shall consider granting waiver of 5% in fees. The said waiver is being offered considering the experience, relating to utilization of various facilities, services etc, during the previous period of Covid-19 pandemic.</p>
13.	<p>The today’s minutes of the meeting on dated 24<sup>th</sup> December 21 are read and approved by all the present EPTA members.</p>
