Minutes of meeting:

1. The principal extended a warm welcome to all E-PTA members.
2. Principal briefed about the best practices of the school, ongoing and future initiatives of the school as well as achievements of the school.
3. The meeting is followed by a main agenda of the E-PTA meet, i.e. compliance of E-PTM meet.
4. Students feedback analysis was presented. It was satisfactory, highly praiseworthy and motivating for the school.
5. Upcoming events of the session 2021-22 were introduced to all E-PTA members.
6. Details of the school outstanding fees for the session 2019-20, 2020-21 and 2021-22 was presented and an appeal was made to all EPTA members to extend their contribution in collection of school outstanding fees.
7. The management of school has informed to all the EPTA members that as a difficulty raised due to prevailing Covid-19 pandemics in resumption and conducting of physical classes in the school though fees increase of 15% over the fees applicable for the academic year 2019-20 was approved for the academic year 2020-21 & 2021-22, but the School Management not increased the approved fees increased of 15% for the academic session 2020-21 and has charged the same fees as was charged in academic year 2019-20.

Considering the fact that the Covid-19 Pandemic has had its damaging effect on the financial condition of several families and to enable the parents to ensure a smooth flow of education of their ward and regular payment of fees to the school the management has considered the request of parents sympathetically and has granted a waiver of 25% in the fees for the academic year 2020-21.

Further to above the management has allowed an increase in the fees of the academic year 2021-22 and additional 10% fees waiver totally to 25% fees waiver solemnly and humanitarian ground.


8. School Management has proposed the increase in school fees by 15% over the increase in school fees by 15% over the fees applicable for the academic year 2021-22.

The above proposal has been considered by the Executive Parents Teachers Association (hereinafter referred to as "EPTA"), Keeping in the mind the various factors mentioned in section 9 of the Maharashtra Educational Institutions (Regulation of fees). Act 2011 (hereinafter referred to as "Said Act") and on finding the aforesaid proposal to be reassembled, the E-PTA has approved the increase of school fees by 15% over the fees applicable for the Academic Year 2021-22. This approved fees will be applicable for the academic sessions 2022-23 and 2023-24.

Though the above increase of fees has been approved by the E-PTA in case of any difficulty in resumption and conducting of physical classes in the school, the school management shall consider granting a waiver of 3% in the fees. The said waiver is being offered considering the experience, relating to utilization of various facilities, services etc. during the previous period of Covid-19 pandemic.
