5.	Fee approval for the sessions 2024-25 & 2025-26	School management has proposed the increase in school fees by 15% over the fees applicable for the academic year 2023-24. The above proposal has been considered by the Executive Parents Teachers Association (hereinafter referred to as "EPTA"), keeping in mind the various factors mentioned in section 9 of the Maharashtra Educational Institutions (Regulation of Fees) Act, 2011 (hereinafter referred to as a "Said Act") and on finding the aforesaid proposal to be reasonable the EPTA has approved the increase of school fees by 15% over the fees applicable for the academic year 2023-24. The approved fees will be applicable for the academic session 2024-25 and 2025-26.
6.	Outstanding fee - An appeal to EPTA	The outstanding fee for the session 2022-2023 and 2023-2024 was shared with the members. An appeal was made to the EPTA members to help in the recovery of the outstanding fees. Suggestions from the members were asked for the recovery.
7.	Future foundation courses	MGS Director Honorable Abha Meghe Madam has introduced the details of Future Foundation Courses which will be implementing from next academic session i.e 2024-25 and appeal to take benefit of the same.
8.	New admission vacancies	Principal has shared all details of new admissions for the session 2024-25 with EPTA members.
